MESSAGE FROM THE CHAIR & CHIEF EXECUTIVE

Orchestras Central Trust has completed another successful year in a positive financial position, delivering performances, workshops, education and enjoyment to a wide range of audiences and communities. A highlight in February and March was the welcome return of the much-loved Hamilton Arts Festival Toi Ora ki Kirikiriroa presentation of TWSO's Sunset Symphony and a candlelit 'classical jazz' concert in the Ancient Egyptian Garden. Some of our other highlights of the 2024 financial year included:

TRUST WAIKATO SYMPHONY ORCHESTRA

Symphony at the Movies in May was the inaugural collaboration with Hamilton City Pops Orchestra, conducted by their Musical Director, Victoria Trenwith. Circus Tricks and Unlikely Friends Whānau concert as part of our Central Celebrates mini festival included *The Juggler* and *Snake and the Lizard* by NZ composer Philip Norman, and featured circus artists Geoff Gilson and Arielle Chaney. From the New World with TWSO's Principal Conductor Emeritus, Rupert D'Cruze featured Dvořák's Symphony No.9 and APO principal clarinettist Jonathan Cohen in Weber's first Clarinet Concerto and New Zealand composer Gareth Farr's *Waipoua*. The programme was performed in both Putāruru and Hamilton.

YOUTH ORCHESTRA WAIKATO (YOW)

Conductor, Simon Brew and Associate Conductor, Catherine Polglase and the YOW tutors delivered a full programme of activity for its members. The residential weekend camp at Maungatautari started off the year, followed by Fire and Romance as part of the Cambridge Autumn Festival and Kaleidoscope, YOW's formal mid-year concert. The now established Showcase Concert with Te Rauhii and Waikato Community School of Music formed part of the 'Central Celebrates' mini festival and the Schools' Tour concerts including Te Rauhii and Tron Songsters took place at the K'aute Pasifika Village Fale, with members of the K'aute Pasifika Early Learning Centre and Pasifika community in the audience. Celebrate the Season finale concert was performed to a large audience to end the year on a high.

The YOW Academy Programme successfully trialled in September and is designed to bridge the gap between starting young musicians and YOW. Eighteen young musicians were guided by Musical Director, Daniel Collins and YOW Associate Conductor, Catherine Polglase and supported by tutors and Senior YOW members as Tuakana Leaders.

RUSTY PLAYER ORCHESTRA

Rusty Player Orchestra, conducted by Catherine Polglase offered relaxed musical sessions through the year for people of all ages and stages and included a visit to Thames. The all-comers orchestra participated in **Music and Dance Connections**, the popular accessible and relaxed collaboration with 'Jammers' from the StarJam Trust.

OCT ENSEMBLE

OCT Ensemble delivered curated projects aligned to Orchestras Central's strategic focus. This included Classical Jazz by Candlelight, Hamilton Arts Festival Toi Ora ki Kirikiriroa and Vivaldi by Candlelight, Cambridge Autumn Festival. Of People and Places experiential concert as part of Central Celebrates featured the world premiere of Michael Williams' Intangible Echoes commissioned by Orchestras Central and supported by Creative New Zealand. The Adventures of Pat the Pātētē by Janet Jennings toured to Cambridge and Putāruru. Ō tātou wāhi mana; ā tātou kōrero | Stories of our Place co-created by Tom Roa (Ngāti Maniapoto, Waikato), Horomona Horo (Ngāpuhi, Ngāti Porou, Taranaki) and Jeremy Mayall was performed at the Koroneihana Commemorations at Turangawaewae Marae Ngāruawāhia.

Orchestras Central continued to provide a wide range of workshops in our skills development programme, which were all well attended and supported. Brass Attack brass ensemble gave performances at Hamilton North School, Horotiu School and Tamahere Model Country School.

Orchestras Central continues to rely on the generosity of funders to deliver to our Waikato community. Last financial year was year two of three years' funding through Creative New Zealand's Toi Uru Kahikatea programme. This multi-year funding ensures we can plan and execute our strategic direction with confidence.

We received continued funding from Lotteries Community Fund in 2023 for our 2024 activities and we are pleased to see this funding relationship continuing. We were pleased to have the continued support of Trust Waikato and its sponsorship of TWSO. Trust Waikato is a valued partner and supporter, and we are extremely grateful for this continued support.

Contributions from our funders enable us to deliver performances, support the development and growth of players, and to share orchestral music to the Waikato. Our major partner, the University of Waikato provides us with a home for management and for our rehearsals and performances. We have ongoing support from three major financial funders, Creative New Zealand, Trust Waikato and WEL Energy Trust, plus Hamilton City Council. We also acknowledge the various Community Trusts that generously support specific activities including in 2024, the Norah Howell Trust, One Foundation and Lion Foundation.

A big thank you to our dedicated board of trustees, who freely give their time and skills. In 2024 we welcomed new trustee Kathryn Lauder and farewelled Mary Christall and David Waine.

And a big thank you to our Chief Executive Catherine Gibson and our staff, musicians, and all the wonderful volunteers for the commitment, and continued flexibility and resilience shown during the year.

We are always excited to deliver extraordinary orchestral experiences for the people of the Waikato.

The Orchestras Central Trust Deed allowed for the appointment of a minimum of four and a maximum of nine Trustees. Kathryn Lauder was appointed in May, Mary Christall retired in February and David Waine retired in August.

Orchestras Central Trustees generously donate their time and expertise in support of the organisation.

GOVERNANCE RESPONSIBILITIES

In its governance role the Board develops strategy and monitors its implementation; and maintains oversight of risks and risk mitigation measures, management and financial performance, as well as funding requirements. The Board holds a Risk Register which is regularly reviewed and a Register of Trustees' Interests to avoid any real or perceived conflicts of interest.

2024 MEETINGS

In 2024 the Orchestras Central Trust Board held five regular meetings either in person, via an online platform or a combination of both, and an annual strategy session. At its AGM/Annual Reporting Meeting in May the Board re-appointed Charity Integrity Audit Ltd.

OUR ORCHESTRAS

Orchestras Central provides governance and professional management for orchestral music in the Waikato. With four orchestras delivering over 35 concerts, workshops, development programmes (+ approximately 70 rehearsals) annually. This 'orchestral ecosystem' is crucial in ensuring the vitality of our region's arts scene.





Statement of Accounting Policies

Orchestras Central Trust For the year ended 31 December 2024

Basis of Preparation

This performance report is prepared in accordance with the XRB's Tier 3 (NFP) Standard. The entity is eligible to apply these requirements as it does not have public accountability and has total annual expenses of less than \$5,000,000. All transactions in the performance report are reported using the accrual basis of accounting. This performance report is prepared under the assumption that the entity will continue to operate for the foreseeable future.

Goods and Services Tax (GST)

The entity is registered for GST. All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.

Income Tax

Orchestras Central Trust is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

Accounts receivable

Accounts receivable comprise amounts owed to the entity by customers or others. This includes any GST receivable from Inland Revenue.

Accounts payable

Accounts payable are amounts owing to suppliers to pay for goods or services that have been acquired in the course of the entity's operations. GST payable to Inland Revenue is also part of creditors.

Property plant and equipment

Property, plant and equipment comprises musical instruments and equipment, and office and computer equipment. Property, plant and equipment is shown at cost, less accumulated depreciation and impairment losses.

Revenue Recognition

Revenue is recognised to the extent that it is probable that the economic benefit will flow to the Trust and revenue can be reliably measured. Revenue is measured at the fair value of the consideration received. The follow specific recognition criteria must be met before revenue is recognised.

Deferred revenue

Deferred revenue comprises subscriptions/membership fees paid in advance for future activity and significant donations, grants, and bequests that have documented expectations from the provider about how or when the funds will be used. As or when documented expectations are satisfied, the deferred revenue balance is reduced, and revenue is recorded.

Donations, Grants and Bequests

Donations, grants, and bequests that have no documented expectations from the provider on how the funds will be used, are recorded as revenue when the funding was received.

Donated goods or services (other than donated assets) are not recognised as income.

Where significant donated assets are received with useful lives of 12 months or more, and the fair value of the asset is readily obtainable, the donation is recorded at the value of the asset obtained. Where the fair value of the asset is not obtainable, the donation is not recorded. Donated assets with useful lives less than 12 months are not recorded.

Changes in Accounting Policies

The Entity has adopted the new Tier 3 (NFP) Standards issued on 18 May 2023 and this Performance report has been completed in line with these Standards. Some minor changes have been made to the groupings of expense items from the previous year's Performance Report. This brings the Performance Report in-line with Charities Service's guidance. There is no change in the overall expenses, and therefore, no change to the Net profit or equity as a result.


